The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

The amendments specifically address NAC 321.300 through NAC 321.365, Protection of the Lake Tahoe Basin. Amendments are proposed to update processes for grant applications.
