Pursuant to the Memorandum of Understanding (MOU) between our agencies, this is to notify you that USDA - Rural Development has received a request for financial assistance from Mineral County, in Hawthorne, NV, for maintenance/repairs of county owned properties as listed below.

Mineral County Courthouse located at 1st and A Street. This project will include roof replacement, new carpet in the hallways, and Americans with Disability Act (ADA) compliant doors at the main entrance of the courthouse.

The Emergency Management building is the building located behind the Courthouse at 1st and A street. This project will include ADA upgrades to the bathroom and kitchen, and the installation of lever door handles. Additional interior walls for more offices, new carpet and paint will also be included with the project.

The Care and Share building is located at 975 K Street. This project will consist of entire roof replacement.

The County Health Nurse building located at 331 1st Street. This project will consist of interior paint only.

The Firehouse located at 418 Mineral Way. This project will consist of new overhead garage doors installed at the truck bays.

The Mineral County Museum located at 400 10th Street. This project will consist of roof leak repairs.

The Mineral County Library located at 110 1st St. This project will consist of leak repairs on the roof.


