Dear Interested Reader:

The Forest Service, Mountain City, Ruby Mountains, Jarbidge Ranger District, is analyzing the impacts of making available for lease approximately 54,000 acres of National Forest System (NFS) land in the Ruby Mountains portion of the District. If made available, these lands may be proposed for oil and gas leasing by the Bureau of Land Management (BLM) in a future BLM lease sale. The Forest is initiating this analysis because we received a request from the BLM asking that we provide leasing concurrence on these specific lands. Enclosed is a map illustrating the location of the proposed lands. More detailed map(s) and a legal description of the lands are available upon request to the District office. This leasing analysis is an administrative decision and does not authorize any ground disturbance. If lands are made available for leasing by the Forest Service and leased through a future BLM lease sale, detailed environmental analysis would be conducted for any ground-disturbing proposal submitted by a future lessee.

This letter serves as the invitation to provide scoping comments as provided for under the National Environmental Policy Act at 40 CFR 1500, and notification of opportunity to comment as provided for under the Forest Service's administrative review regulations at 36 CFR 218.24. This project is not authorized under the Healthy Forests Restoration Act (HFRA); however it is subject to the Pre-decisional Administrative Review Process under 36 CFR §218 Subparts (A) and (B).

The lands are located south of Lamoille Creek and North of Sherman Creek, on the west side of the Ruby Mountains. These lands are within areas covered by the 1986 Humboldt Land and Resource Management Plan (LRMP), and all are designated as open to leasing.

This Project proposal will be analyzed in an environmental assessment (EA) as required by the National Environmental Policy Act (NEPA) and Forest Service policy. To aid the Forest Service with the environmental analysis, we are accepting any input, recommendations and concerns you may have with this proposal. The BLM is a cooperating agency on this project.

As part of the analysis, the Forest Service will decide if all or a portion of these NFS lands are available or are not available for leasing. For any lands made available, the Forest Service would need to identify reasonable and necessary stipulations that would be attached to the lease for a given legal description to avoid or minimize impacts to resources such as wildlife, soils, watersheds, roadless area characteristics and cultural resources. Stipulations are written to conform to the approved land use plans governing Forest Service management of resources in the area to be leased, and consistent with laws, regulations, policies, rules, and orders.



Based upon an initial review of the lands, the following stipulations are being considered:

No surface Occupancy Stipulation for:

- Greater sage-Grouse Priority Habitat Management Areas (PHMA).
- Occupied Lahontan Cutthroat Trout stream corridors
- Lands with slopes greater than 40%
- Occupied Rare Plant Habitat
- Riparian habitats and wetlands

Controlled Surface Use Stipulation for:

- Greater sage-Grouse general habitat management areas (GHMA)
- Inventoried Roadless Areas

Timing Limitation Stipulation for:

- Crucial mule deer winter range
- Active raptor nests
- Migratory bird nesting areas

The opportunity to comment ends 30 days following the date of publication for the legal notice for this project in the *Elko Daily Free Press* (Newspaper of Record). The publication date in the newspaper of record is the exclusive means for calculating the comment period for this analysis. Those wishing to comment should not rely upon dates or time frame information provided by any other source. Only those who submit timely and specific written comments regarding the proposed project during a public comment period established by the responsible official are eligible to file an objection under 36 CFR §218.

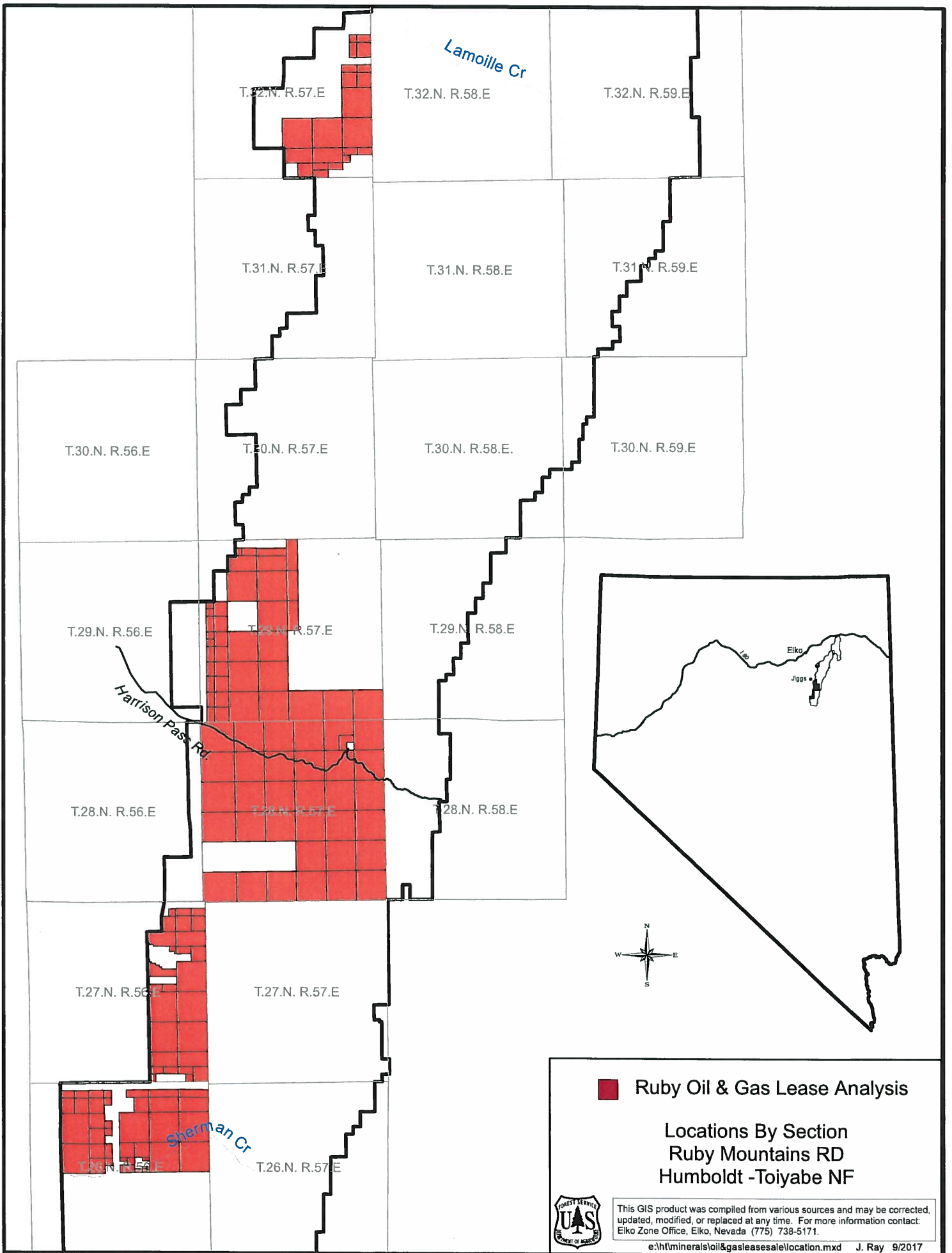
